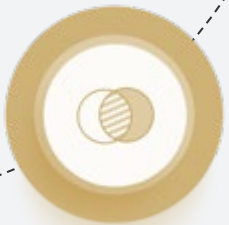
Purpose of the PBO



To create a **more level playing field for all parliamentarians**



To ensure the **accuracy of election commitment costings**



To **improve transparency**, particularly around budget information and budget-related issues

Purpose of the PBO



Policy costings & budget analysis

Prepare high quality policy costings and budget analyses at the request of parliamentarians in a timely manner.

Develop and maintain our costing and projection models and databases.



Self-initiated activity

Publish research papers that promote a better public understanding of the budget and fiscal policy settings, with a particular focus on the sustainability of the budget over the medium term.



Election commitments report

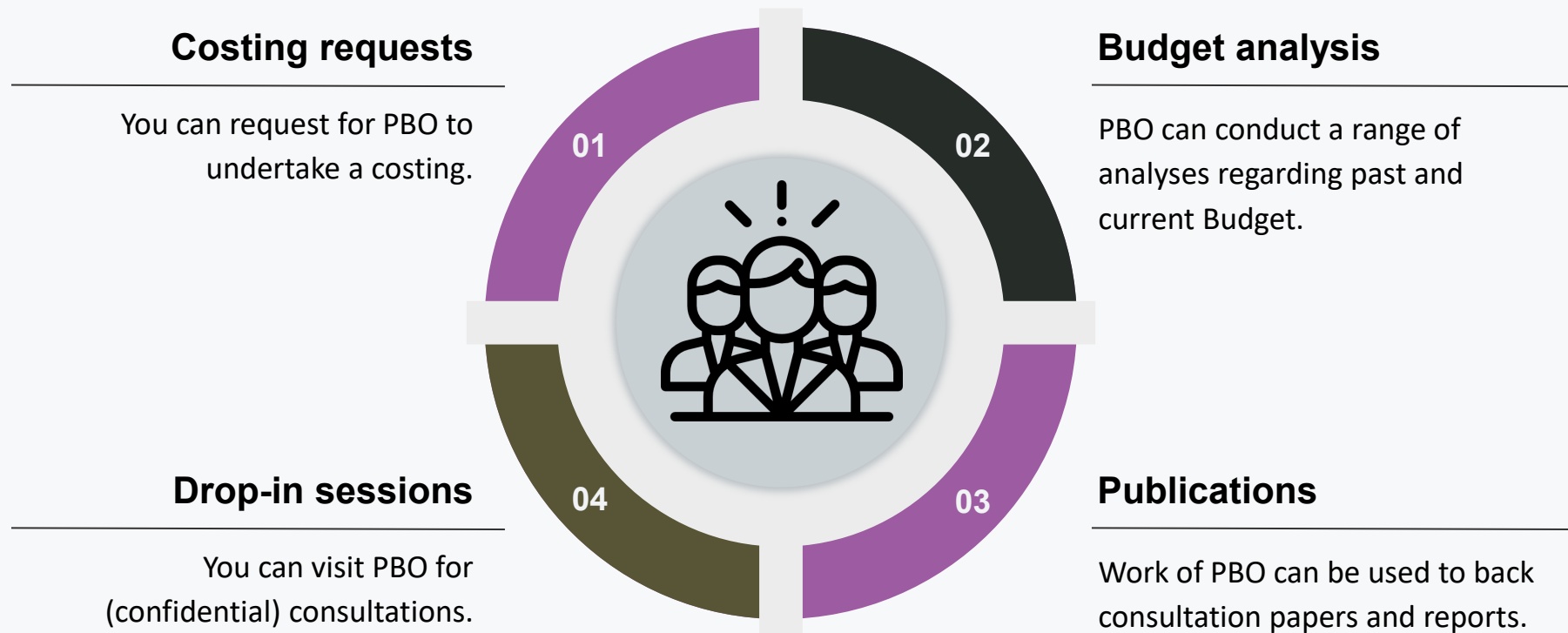
Prepare and publish a report analysing the budget impact of the election commitments of parliamentary parties after the next general election.

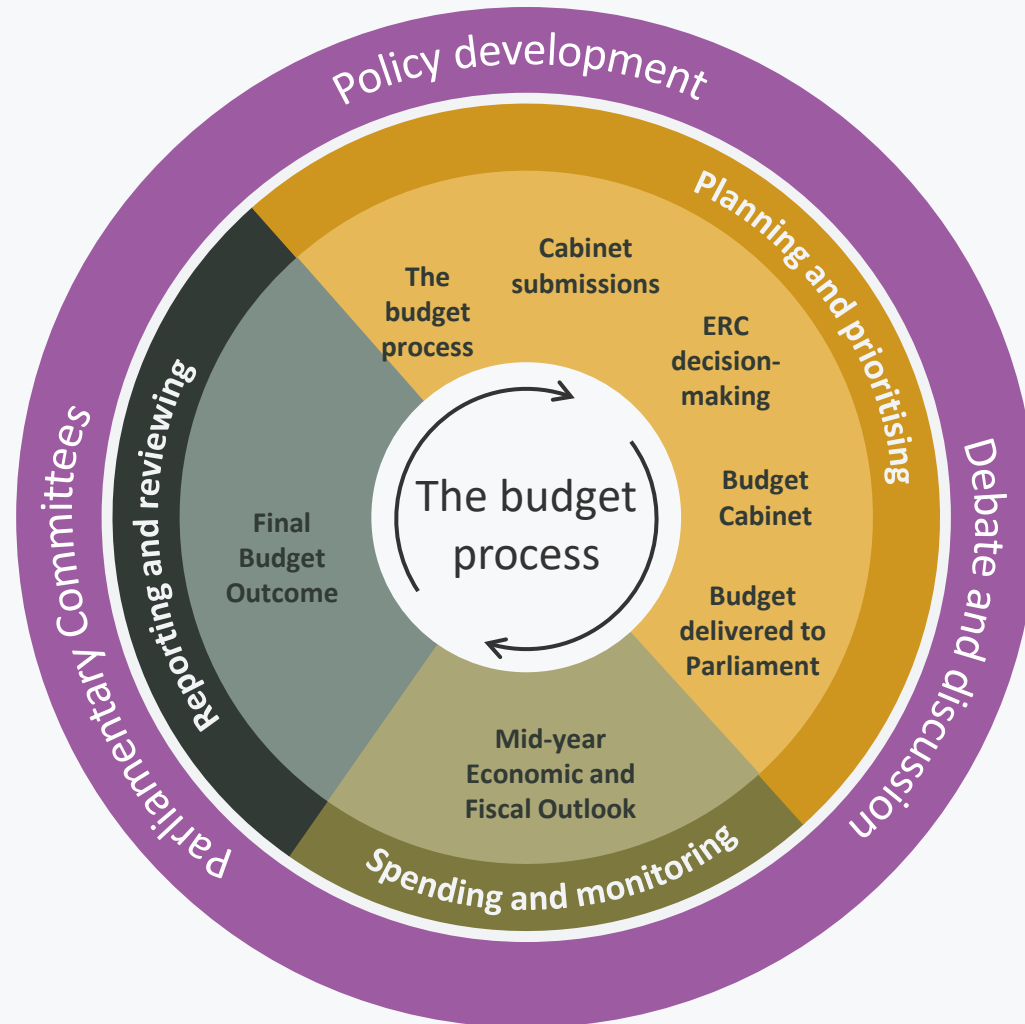
How we can help you



Understand the Budget process

The **budget process** allocates public resources to the Government's policy priorities.

Parliament provides the authority to spend money through the passage of the annual appropriation acts and other legislation



Our services

- You can request a costing from the PBO on a policy proposal. Requests will be confidential if made outside of the caretaker period.
- Costings and analysis services are designed to support you to participate in a more informed policy debate.
- We can't give you direct policy advice, but we can assist by discussing how different policy options could generate different impacts.



Costing of policy proposals

A costing is an assessment of the financial impact of a proposed policy change on the Commonwealth Government budget.



Budget analysis

A budget analysis assists in evaluating existing policies, or what affects a policy change would have on the budget or on different groups of people.

Confidentiality

A request and the response will be kept confidential. We won't make public any information unless you release it or authorise us to publish it on our website.

This is different during a caretaker period before a general election when any costings requested during this period must be made public.

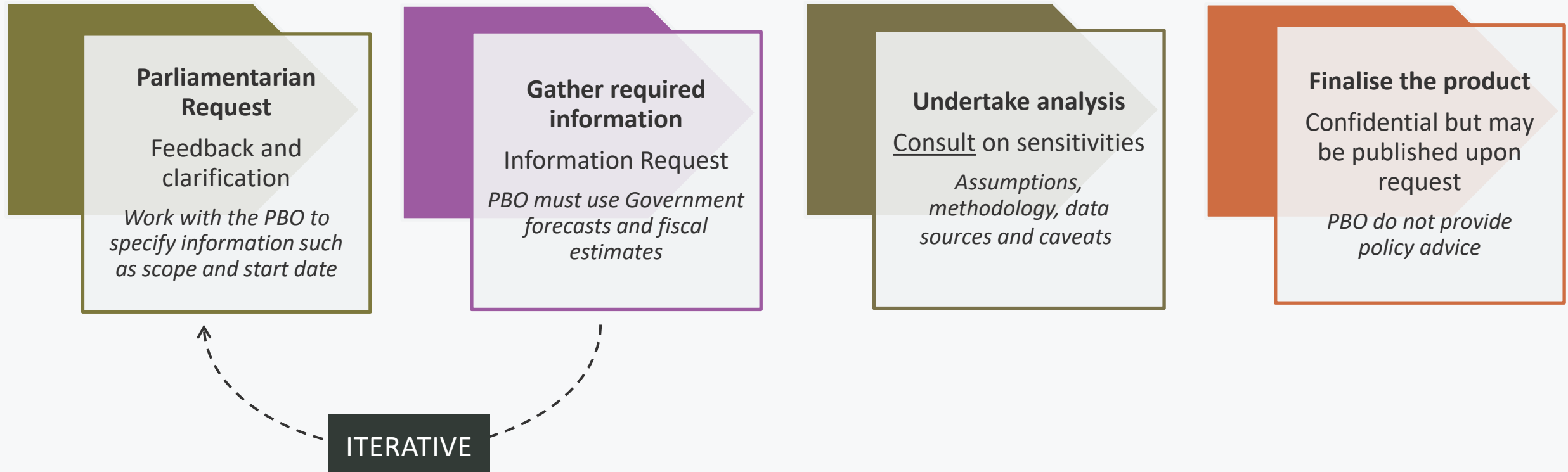
PBO information papers are published to help explain, in an accessible way, the underlying data, concepts, methodologies and processes that the PBO uses in preparing costings of policy proposals and budget analyses. The focus of PBO information papers is different from that of PBO research reports which are aimed at improving the understanding of budget and fiscal policy issues more broadly.

Overview

Every year, we prepare a large number of policy costings for parliamentarians. In 2016–17, for example, we prepared over 1,600 policy costings. Each costing provides an estimate of the proposed policy's financial implications on the Australian Government Budget over the next decade.

The costing process

The PBO works closely **with agencies** and **negotiates with requestors** to seek to deliver a good outcome.

Making a request

We encourage you to discuss your request with us prior to formally submitting it, particularly if you have questions on how to specify the request. These conversations are confidential and can greatly assist both PBO analysts and you to understand the detail of a query and to shape the formal request. A formal request for costing or analysis must be submitted by the parliamentarian to pbo@pbo.gov.au. Each request:

- must include a signed letter from the parliamentarian, or email from the parliamentarian's @aph.gov.au email account, that is addressed to the Parliamentary Budget Officer
- should include a completed PBO request template (see below).

You will receive an acknowledgement and a tracking number by email once your request is registered. The tracking number makes each request easier to identify in future correspondence.

You must include...


Parliamentarian approval

- Request MUST be submitted by your parliamentarian
 - come from their **@aph.gov.au** email address
- OR
- include a signed letter from them

Completed template

- Key information about who to contact
- Specifics about what to include in the costing analysis

Costings

Publicly released costings or budget analyses outside the caretaker period.

The Parliamentary Budget Officer has publicly released the following costings, either because they were not requested on a confidential basis, or following advice from the parliamentarian that they are no longer confidential. The PBO's Post-election reports also contain costings for each of the election commitments made by the major parties.

Policy costings are estimated using the most recent information available at the time they are provided. All PBO costings have an 'expiry date', which is usually the date of the next budget update. Care should be taken when referring to policy costings that are no longer current as the estimated cost of the policy proposal could change substantially with new information. If you would like advice on whether the estimated financial impacts of a costing remain relevant, please contact the PBO.
