# 2025 PBO Election commitments report key dates

Note: This guidance will be updated with specific dates following the issuing of the writs for the 2025 general election.

This guidance note provides information on the 2025 Election commitments report (ECR) prepared by the Parliamentary Budget Officer, including arrangements for engagement with parliamentary parties.

#### In summary:

- The Parliamentary Budget Officer will be preparing a report of the budget impacts of the major parliamentary parties' election commitments.
- Major parties (those with more than 5 members in Parliament prior to the election being called) are automatically included in the ECR.
- Minor parties and independent parliamentarians who wish to opt in to the 2025 ECR will need to
  advise the Parliamentary Budget Officer of their intention by [5pm on Saturday 2 weeks prior to
  polling day].
- Political parties included in the ECR will need to provide the Parliamentary Budget Officer with a list of their publicly announced policies by [5pm on the Friday, the day before polling day].
- The Parliamentary Budget Officer is required to publish these lists on the day after polling day.
- Three days after the end of the caretaker period, the Parliamentary Budget Officer is separately required to provide to major parties, the election commitments that the Parliamentary Budget Officer determines have a material effect on the budget.
- The 2025 ECR will be published by the later of the following dates: 30 days after the end of the caretaker period, or 7 days before Parliament first sits.
- Each party or independent parliamentarian in the ECR will receive a confidential copy of its part of the report at least 48 hours before release of the ECR. The Parliamentary Budget Officer may, if practical to do so, include any comments from the party in the report, or may revise the report.
- During the caretaker period for a general election, the Parliamentary Budget Office (PBO) is also available to undertake costings of policy proposals. <u>PBO general election guidance 2, 2024: Costing</u> <u>policy proposals during the caretaker period</u> provides advice on caretaker costings.

Further details about the ECR are provided in the questions below.

#### Whose election commitments are included in the ECR?

The Parliamentary Budget Officer is required to prepare a report of the budget impacts of the major parliamentary parties' election commitments. Major parliamentary parties are those that have at least 5 members in the Parliament immediately before the commencement of the caretaker period.

Independent members and parliamentary parties with fewer than 5 members ('minor parties') are able to opt in to the 2025 ECR. For the purposes of this note, 'minor parties' may refer to all independent parliamentarians and parliamentary political parties with fewer than 5 Members or Senators.

#### Which election commitments are included in the ECR?

The Parliamentary Budget Officer ultimately decides which commitments should be included in the ECR, based on announcements made by the parties prior to polling day and any associated fiscal impact. The PBO's legislation (subsections 64MA(3) to (8) of the *Parliamentary Service Act 1999*) sets out how the Parliamentary Budget Officer must seek and may take into account feedback from major parties.

- Parliamentary parties must submit a list of their election commitments to the PBO by [5pm on Friday day before polling day] and the PBO must publish these lists on the day after polling day. It is the PBO's expectation that parties submit their election commitments using the election commitments template available on the PBO website.
- The PBO separately tracks and identifies election commitments made by parties during the campaign and must provide its list to each party within 3 days after the end of the caretaker period.
- The PBO's list could differ from that submitted by a party if the PBO identifies more or fewer announced election commitments with material financial implications, or differences between the announced and listed version of commitments.
- In determining the list of commitments it provides to parties, the PBO will consider whether any announcements made during the election campaign, and not included on the list provided by the party, constitute election commitments for the purposes of the ECR. In forming this judgement, the Parliamentary Budget Officer will consider a range of factors, particularly including who made the statement and the nature of the commitment made.
- For example, some announcements made during the election campaign may be judged by the PBO
  to be aspirational in nature because no firm commitment was made to the policy mechanism or
  delivery. In this case the PBO would be unlikely to include the announcement as an election
  commitment in the ECR. Where an announcement involves detailed actions to achieve an
  aspirational target, the PBO would include the commitment in the report.
- In the event that an announced commitment differs somewhat from a similar commitment provided to the PBO as part of the party's list of election commitments, the PBO will err on the side of treating the commitment as new rather than an expansion of an existing commitment.

The arrangements for determining minor parties' election commitments mirror those in legislation for the major parties. Further information on the process for compiling the list of election commitments for each party is at Appendix A and a summary of the ECR arrangements for major and minor parties is at Appendix B.

#### What information is provided in the ECR?

The ECR must include costings of all the election commitments that the Parliamentary Budget Officer, in their best professional judgement, reasonably believes would have a material impact on the Commonwealth budget estimates for the current financial year and the following 3 financial years (the forward estimates period).

The ECR will also include the costings of the impact of each party's individual election commitments and their combined impact on the budget over the medium term.<sup>3</sup>

If a party announces a policy capping of tax receipts or expenditure, or if government policy detailed in Pre-election Economic and Fiscal Outlook (PEFO) includes a policy of capping tax receipts or expenditure, the PBO will include this as a separate commitment, and cost it accordingly.

The ECR must, for each major party, also include:

- any comments provided to the Parliamentary Budget Officer in response to the list of election commitments provided to the party, or a statement that no comments were provided
- an explanation of why each policy included in the report is taken to be an election commitment
- the source (or sources) of information from which the Parliamentary Budget Officer identified each election commitment.

The ECR may also include a statement about any election commitments that were not included because insufficient information or time was provided, if relevant.

ECR costings will be prepared using the methods and approaches set out in the *2024 Charter of Budget Honesty Policy Costing Guidelines* issued jointly by the Secretaries to the Treasury and the Department of Finance.<sup>4</sup>

The report does not have to include information that the Parliamentary Budget Officer considers is confidential commercial information or which could prejudice national security.

The detailed costing documentation for individual election commitments in the 2025 report will include the distributional impacts of commitments on an opt-in basis. Where parties have previously requested distributional impacts of their election commitments as part of a PBO costing outside of the caretaker period, they may choose to retain them in the updated costing published in the report.

#### What must minor parties and independents do to opt in?

Since the 2019 general election, minor parties (with fewer than 5 Members or Senators) and independents have had the option of having the financial impact of their election commitments included in the report of election commitments with financial implications.

Minor parties and independents wishing to opt in to the 2025 ECR must notify the Parliamentary Budget Officer of their intention to do so by [5pm on Saturday, 2 weeks prior to polling day]. As noted above, any minor party or independent opting in must provide the Parliamentary Budget Officer with a list of publicly announced policies before [5pm on Friday the day prior to polling day].

For any minor parties and independents that choose to opt in to the ECR, the Parliamentary Budget Officer will aim to release the financial implications of their election commitments at the same time as the report on the major parties, if time allows. If it is not possible to release the information at the same time, it will be released in an addendum as soon as possible after the release of the main report. A minor party or independent can opt out of the ECR any time up until 5pm on the day before election polling day, [Friday the day prior to polling day]. A notification to opt out should be provided in writing to the Parliamentary Budget Officer.

If a minor party opts in to the election commitments report addendum and no longer has a representative in the Parliament following the election, their commitments will be excluded from the report addendum on the basis that they will no longer have an ongoing role in budget-related deliberations.

#### How is information gathered for the ECR?

The Parliamentary Budget Officer may seek information regarding election commitments from an authorised member of the relevant party or any other person who it is reasonable to believe has been associated with the calculation, review or announcement of the financial implications of the election commitment. Where parties have previously requested distributional impacts of their election commitments as part of a PBO costing outside of the caretaker period, the PBO will ask nominated contact officers whether that material would be retained in the updated costing published in the report.

The Parliamentary Budget Officer may also seek information from the Head of a Commonwealth body. This will include obtaining information from the Secretaries to the Treasury and the Department of Finance in respect of the caretaker period costings they have prepared under the *Charter of Budget Honesty Act 1998*.

#### How and when will the ECR be published?

The Parliamentary Budget Officer must publicly release the ECR by the later of:

- 30 days after the end of the caretaker period for the general election
- 7 days before the first sitting day of either or both Houses of the Parliament after the general election.

The Parliamentary Budget Officer will provide each major party with a confidential copy of the part of the report setting out the costings and totals of that party's election commitments at least 48 hours before publicly releasing the ECR. The Parliamentary Budget Officer may include any comments received from parties in the final report, or may revise the report to take account of the comments.

Once the ECR is finalised, the Parliamentary Budget Officer will advise the major parties at least one hour in advance of the public release of the report. The report will be emailed to all major parties immediately prior to its release.

For the minor parties and independents that opt-in to the ECR, the Parliamentary Budget Officer will aim to release the financial implications of their election commitments at the same time as the report on the major parties, if time allows. The Parliamentary Budget Officer will provide each minor party and independent with a confidential copy of the relevant part of the report setting out the costings and totals of their election commitments at least 48 hours before publicly releasing the ECR.

If there is an addendum to the ECR, containing the financial implications of the commitments of minor parties or independents that opt in, it will be published as soon as possible after the release of the main report. As with the main report, a confidential copy of the relevant section of the addendum will be provided to each minor party and independent that chooses to opt in at least 48 hours before it is publicly released.

The Parliamentary Budget Officer may include any comments received from minor parties or independents in the final addendum, or may revise the addendum to take account of the comments. Once the addendum is finalised, the Parliamentary Budget Officer will advise the relevant minor parties and independents at least one hour in advance of its public release.

### Appendix A: Election commitments lists: summary of arrangements for major and minor parties

#### Major parties

The process for compiling the list of election commitments for each major party is as follows:

- 1. Each major party must, before [5pm on Friday the day prior to polling day], provide the Parliamentary Budget Officer with a list of its publicly announced policies. Minor parties and independents wishing to opt in to the ECR must also meet this requirement. It is the PBO's expectation that parties submit their election commitments using the election commitments template.
- 2. On the day after polling day (Sunday), the Parliamentary Budget Officer must release each list of commitments that has been provided, or where no list has been provided, a statement to that effect.
- 3. Within 3 calendar days of the end of the caretaker period the Parliamentary Budget Officer must, for each major party:
  - provide the party with a list of election commitments that, in their best professional judgement, would have a material effect on the budget, having regard to the lists provided by the party and any public announcements made by the party before or during the caretaker period
  - provide the party with a statement explaining the reason(s) for any differences, in the event that
    the list prepared by the Parliamentary Budget Officer differs from the list of election
    commitments provided by the party.
- 4. Each major party has 3 calendar days to provide the Parliamentary Budget Officer with comments on the list of its election commitments. The Parliamentary Budget Officer may take account of such comments, but is not required to do so.

The ECR must only include costings of election commitments that are included in the list the Parliamentary Budget Officer provides to a party, or additional commitments in the response a party provides to that list.

#### Minor parties and independents

The process for compiling the list of election commitments for minor parties and independents choosing to opt in to the ECR broadly replicates the process for major parties:

- Each party or independent must, before [5pm on Friday the day prior to polling day], provide the
  Parliamentary Budget Officer with a list of its publicly announced policies. It is the PBO's
  expectation that parties submit their election commitments using the election commitments
  template.
- 2. On the day after polling day (Sunday), the Parliamentary Budget Officer will publish each list of commitments that has been provided, or where no list has been provided, a statement to that effect.
- 3. In preparing the ECR, the Parliamentary Budget Officer may amend the commitments list provided and, in that case, would provide the party or independent with a statement of reasons for this amendment. The PBO would endeavour to match the legislated timeframe applying to major parties.

Note: a designated party for the purposes of the Election commitments report is one with 5 or more Members or Senators. A minor party is one with fewer than 5 Members or Senators.
