Summary of proposal:							
The proposal would provide \$9 billion over 10 years as a contribution to climate finance to support							

The proposal would provide \$9 billion over 10 years as a contribution to climate finance to support those nations facing loss and damage.

The proposal would be ongoing, distribute funding evenly over 10 years, include departmental funding within the cap, and would start from 1 July 2026.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$2.7 billion over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 10 years from the commencement date. Departmental costs are assumed to be small and able to be absorbed by the relevant department, as funding is assumed to be contributed to the United Nations Loss and Damage Fund. Administered expenses are as specified in the proposal. We assume no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
