Expanding the Goanna Academy								
Party:	Australian Labor Party							
Summary of proposal:								
The proposal would provide \$6.4 million over 3 years to the Goanna Academy to expand its preventative mental health education programs and pilot a new mental health training program, 'Goanna Champions'.								

The funding profile for the grant would be \$2.5 million in 2025-26, \$2.0 million in 2026-27, and \$1.9 million in 2027-28.

The proposal would be non-ongoing and start from 1 July 2025.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$6.4 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, distributed over 3 years from the commencement date as specified. As funding would be provided to the Goanna Academy directly, there would be no significant departmental costs, and these would be absorbed by the relevant department. Administered costs are as specified. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
