<p>Summary of proposal:</p> <p>The proposal would provide \$82.9 million over 3 years from 2025-26 to fund local environmental projects around Australia.</p> <p>The proposal would provide funding of \$32.9 million in 2025-26 and 2026-27, and \$17.1 million in 2027-28. The projects that would receive funding under this proposal are listed in Attachment B.</p> <p>The proposal would be non-ongoing and would start from 1 July 2025.</p>	

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$85.9 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

A breakdown of project funding is provided in Attachment B.

Key assumptions and methodology

The proposal is capped at a fixed amount, distributed over 3 years from the commencement date as specified. Departmental expenses were estimated based on the cost of administering similar programs and are assumed to be in addition to the capped funding amount. Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
