Providing inclusive, culturally safe healthcare for LGBTIQA+ Australians

### Summary of proposal:

The proposal would provide \$10 million over 3 years to support primary healthcare providers to improve their skills and knowledge to deliver inclusive LGBTIQA+ healthcare. A training provider will be selected through a competitive grants process.

The funding will also support the introduction of a voluntary accreditation program so that healthcare providers can be recognised for meeting best practice for LGBTIQA+ care, helping patients identify safe and trusted services.

The funding will be profiled as \$4 million in 2025-26 and \$3 million in both 2026-27 and 2027-28.

The proposal would be non-ongoing and start from 1 July 2025.

### Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$10 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

# Key assumptions and methodology

The proposal is capped at a fixed amount, distributed as specified from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>

### Data sources

Departmental expenses were informed by similar measures in the Commonwealth budgets from 2015-16 to 2021-22.
