### Summary of proposal:

The proposal would provide \$744,000 over 4 years for the Kokoda Track Memorial Walkway. This funding is in addition to the existing support for the walkway, including \$186,000 to be delivered in 2025-26.

The proposal would be non-ongoing, distribute funding evenly over 4 years and start on 1 July 2026.

### Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$0.5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

# Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 4 years from the commencement date. Departmental expenses associated with providing funding to Kokoda Track Memorial Walkway are expected to be small and are assumed to be absorbed within existing resources of the relevant department. Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
