



Constructing a Health and Engineering Wing at CQUniversity in Cairns	
Party:	Australian Labor Party
Summary of proposal: The proposal would provide \$27.5 million over 2 years to construct a Health and Engineering Wing at the CQUniversity's Cairns campus. The facility would open in 2028. The proposal would be non-ongoing, with funding split evenly over the 2 years of the proposal. The proposal would start from 1 July 2025.	

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$27.5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount evenly distributed over 2 years from the commencement date. Departmental expenses associated with providing funding to the CQUniversity are expected to be small and are assumed to be absorbed within existing resources of the relevant department. Administered expenses are as specified. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
