Recycling mobile phones to assist victims of domestic violence

Summary of proposal:

The proposal would provide \$2 million over 4 years to support organisations recycling mobile phones for victim-survivors of family and domestic violence, especially small, community-based groups.

The proposal would be non-ongoing, distribute funding evenly over 4 years and start on 1 July 2025.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$2 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) impacts. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 4 years from the commencement date. Departmental expenses associated with providing funding to organisations that recycle mobile phones for victim-survivors of family and domestic violence are expected to be small and are assumed to be absorbed within existing resources of the relevant department. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
