Domestic violence community training grant program									
Party: The Coalition									
Summary of proposal:									
The proposal would provide grant funding of \$10 million over 4 years to support community organisations to deliver domestic violence awareness training and help prevent these horrific crimes.									
The proposal would be non-ongoing, distribute funding evenly over 4 years and start on 1 July 2025.									

#### Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$10 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

#### Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 4 years from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
