



Outcomes-based indigenous health delivery – CareFlight investment

<p>Summary of proposal:</p> <p>The proposal would provide \$10 million in 2025-26 to support CareFlight acquire an additional King Air B250 fixed wing aircraft to better service the Top End. The additional aircraft would supplement CareFlight’s current fleet of fixed wing aircraft servicing remote communities in the Top End and would provide additional care for approximately 700 patients per year.</p> <p>The proposal would be non-ongoing and start from 1 July 2025.</p>	

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$10 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount as specified in the proposal. Departmental expenses associated with providing funding to CareFlight are expected to be small and are assumed to be absorbed within the relevant department. Administered costs are as specified. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
