<p>Summary of proposal:</p> <p>The proposal would provide \$102.2 million in grant funding over 3 years to support safer and more connected communities.</p> <p>The funding profile would be \$52.2 million in 2025-26, \$35 million in 2026-27 and \$15 million in 2027-28.</p> <p>The proposal would start on 1 July 2025.</p>	

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$106.3 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, distributed over 3 years from the commencement date as specified. Departmental expenses were estimated based on the cost of administering similar programs and are assumed to be in addition to the capped funding amount. Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
