### Summary of proposal:

The proposal would provide \$11.5 million over 2 years to support Invictus Australia's ongoing work and to prepare a bid for Australia to host the Invictus Games in 2031. This proposal would replace the existing 2025-26 Budget commitment.

The proposal would be non-ongoing, with funding distributed evenly over 2 years, and would start from 1 July 2025.

### Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$8.2 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The 2025-26 Budget allocated \$3.3 million in 2025-26 to extend grant funding for Invictus Australia for 1 year to 30 June 2026<sup>1</sup>. Accordingly, this proposal would provide an additional \$8.2 million, for an \$11.5 million total commitment. The additional \$8.2 million would be distributed as \$2.4 million in 2025-26 and \$5.8 million in 2026-27, so that the total commitment is distributed evenly over 2 years.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

# Key assumptions and methodology

The proposal is capped at a fixed amount, distributed over 2 years from the commencement date as specified and accounting for the existing \$3.3 million budget commitment in 2025-26. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>2</sup>

### Data sources

Departmental expenses were informed by similar measures in the Commonwealth budgets from 2015-16 to 2021-22.
