



Outcomes-based Indigenous health delivery – Tresillian Family Care Centre

<p>Summary of proposal:</p> <p>The proposal would provide \$7.6 million over 4 years to Tresillian to establish a post-natal family care centre in Katherine, and to purchase vehicles to service surrounding remote areas.</p> <p>The funding would be distributed as \$2.1 million in 2025-26, \$1.8 million in 2026-27 and 2027-28, and \$1.9 million in 2028-29.</p> <p>The proposal would be non-ongoing and start from 1 July 2025.</p>	

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$7.6 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, distributed over 4 years from the commencement date as specified. Departmental expenses associated with providing funding to Tresillian are expected to be small and are assumed to be absorbed within existing resources of the relevant department.

Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
