LGBTIQA+ - Ending discrimination - Assessment of asylum applications

### Summary of proposal:

The proposal would provide \$500,000 per year in funding (\$5 million over the medium term) to ensure adequate and appropriate training for departmental staff so that they are equipped to appropriately assess applications from LGBTIQA+ people seeking asylum.

The proposal would be ongoing, not be indexed and would start from 1 July 2026.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$1.5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

# Key assumptions and methodology

The proposal is capped at a fixed amount, provided annually from the commencement date. All funding is departmental in nature and is not indexed. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
