Women policy portfolio – Women's health – Free public abortion care									
Party:	Australian Greens								

Summary of proposal:

The proposal would provide \$100 million a year to ensure all public hospitals provide abortion services.

The proposal would be ongoing, indexed to the Consumer Price Index (CPI), include departmental costs within the capped amount, and would start from 1 July 2025.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$415 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, provided annually from the commencement date as specified and indexed to CPI. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
