Implement the recommendations of the interim report from the Royal Commission into Defence and Veteran Suicide						
Party:	Australian Greens					

Summary of proposal:

The proposal would provide \$100 million over 10 years to implement the recommendations of the Royal Commission into Defence and Veteran Suicide's interim report, including changes to public immunity protection.

The proposal would be ongoing, not indexed, distribute funding evenly over 10 years and start on 1 July 2026.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$30 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 10 years from the commencement date. Departmental expenses are as specified. We assume that no funds allocated to a given year are left unspent.
