Women policy portfolio – ending violence against women – Domestic Violence Disclosure Scheme

Summary of proposal:

The proposal would provide \$3.3 million in 2026-27 to rollout a national Domestic Violence Disclosure Scheme to help people who may be at risk of domestic violence to find out if their current or former partner has a history of violent criminal offences.

The proposal would be non-ongoing and start from 1 July 2026.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$3.3 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

Departmental expenses are capped at a fixed amount in 2026-27 as specified. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
