



Establish an office to investigate and prosecute war crimes	
Party:	Australian Greens
Summary of proposal:  The proposal would provide \$10 million per year to establish and support a dedicated permanent body that can investigate and prosecute war crimes.  The proposal would be ongoing, not be indexed and start from 1 July 2026.	

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$30 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed ongoing annual amount from the commencement date. Departmental expenses are as specified in the proposal. We assume no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
