LGBTIQA+ - ending discrimination - community funding and public education

Summary of proposal:

The proposal would provide funding to end LGBTIQA+ discrimination through the following components:

- **Component 1:** \$10 million, evenly distributed over 4 years, for a public education campaign to promote inclusion and understanding for trans and gender-diverse people.
- **Component 2:** \$1 million per year ongoing, not indexed (\$10 million over the medium term) for community leadership and development including training for community leaders and trans and gender-diverse community groups.

The proposal would include departmental funding from within the capped amount and would start from 1 July 2026.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$10.5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, distributed as specified for each component from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
