



Waste and recycling – food organic garden organic waste – \$250 million to local councils for national FOGO bins rollout

Party: Australian Greens

Summary of proposal:

The proposal would provide \$250 million over 5 years to local councils to accelerate the rollout of Food Organics and Garden Organics (FOGO) bins for households nationwide.

The proposal would be non-ongoing, not be indexed, distribute funding evenly over 5 years and include departmental expenses from within the capped amount.

The proposal would start from 1 July 2026.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$150 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed over 5 years from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
