Summary of proposal:

The proposal would provide \$250 million per year to universities to ensure support and access to essential facilities and services for international students, specifically for travel and health services, and affordable student accommodation.

The proposal would be ongoing, not indexed, include departmental funding within the capped amount and start from 1 July 2026.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$750 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed annual amount, ongoing from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
