Summary of proposal:

The proposal would provide \$5 billion over 4 years to establish a Protected Areas Fund to expand and protect high-biodiversity regions, including World Heritage protection for the Great Australian Bight, and \$50 million for the creation of new National Parks across Tasmania.

The funding would be distributed as \$500 million in 2025-26 and 2026-27, \$1.5 billion in 2027-28 and \$2.5 billion in 2028-29, with departmental funding in addition to the capped amount.

The proposal would be non-ongoing and start from 1 July 2025.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$5.1 billion over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, distributed as specified over 4 years from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are in addition to the capped funding amount. Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.
