Community engagement in Indian Ocean Territories

Summary of proposal:

The proposal would provide \$5 million in 2026-27 to Parks Australia to support local communities in Indian Ocean Territories for research, monitoring, and engagement in Christmas Island and Cocos (Keeling) Islands Marine Parks.

The proposal would be non-ongoing and start on 1 July 2026.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) impacts. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount of departmental expenses, distributed in 2026-27. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
