<p>Summary of proposal:</p> <p>The proposal would provide \$100 million over 7 years to advance the development of alternative proteins and support a greener, sustainable food system. This would include:</p> <ul style="list-style-type: none">• component 1: \$60 million over 7 years to establish cellular agriculture centres of excellence to accelerate research and innovation• component 2: \$20 million over 3 years to coordinate research efforts for a task force linking programs like CSIRO's Future Protein Mission to other research initiatives• component 3: \$20 million over 3 years to support local businesses to expand operational capacity and build facilities for processing Australian-grown plant proteins. <p>The proposal would be non-ongoing, distribute funding evenly over the timeframe for each component and include departmental funding from within the capped amounts.</p> <p>The proposal would start from 1 July 2026.</p>	

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$65.6 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed as specified from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
