



End Australia's epidemic of violence against women and children – National toll of women killed by violence

Party: Australian Greens

Summary of proposal:

The proposal has 2 components:

- **component 1:** provide \$2 million over 4 years to establish a national real-time toll of women killed by violence. Funding would be evenly distributed over 4 years.
- **component 2:** provide \$4 million to commission a national prevalence study on perpetration of violence against women and children to be undertaken by the Australian Bureau of Statistics (ABS) every 5 years ongoing (in 2026-27, in 2031-32, and so on) and not be indexed.

The proposal would start on 1 July 2026.

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$5.5 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

Component 1

The proposal is capped at a fixed amount of departmental expenses, evenly distributed over 4 years from the commencement date.

Component 2

The proposal is capped at a fixed amount of departmental expenses, every 5 years from the commencement date.

For all components, we assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
