



**End Australia's epidemic of violence against women and children – increase funding for the National Plan to End Violence Against Women**

Party: Australian Greens

**Summary of proposal:**

The proposal would provide \$12 billion over 12 years to increase funding for all existing programs (including for housing) under the National Plan to End Violence Against Women and Children 2022-2032.

The proposal would be non-ongoing, distribute funding evenly over 12 years, include departmental funding from within the capped amount, and start on 1 July 2025.

**Additional specifications (based on further advice provided):**

The proposal would provide an additional \$10 million distributed evenly over 4 years for research to determine the unmet need in frontline support services.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$4 billion over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed amount, evenly distributed as specified for each component from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>

## Data sources

Departmental expenses were informed by similar measures in the Commonwealth budgets from 2015-16 to 2021-22.
