Immigration – Fairness and compassion for refugees – Support LGBTIQ+ refugees								
Party:	Australian Greens							
Summary of proposal:								
The proposal would provide \$40 million over 4 years to support LGBTIQ+ refugees with an internal target, funding, and tailored assistance to protect them from persecution.								
The proposal would be non-ongoing, distribute funding evenly over the 4 years of the proposal and start from 1 July 2026.								
Additional information (based on further advice provided):								
Departmental funding is provided in addition to the capped amount.								

# Costing overview

The proposal would be expected to increase the fiscal and underlying cash balances by around \$31.8 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed administered amount, evenly distributed over 4 years from the commencement date. Departmental expenses were estimated based on the cost of administering similar programs and are not included within the capped funding amount. Administered expenses are as specified in the proposal. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>
