Establishing a \$2 billion Building Rural Hospitals Fund

Summary of proposal:								
The proposal would establish a \$2 billion Building Rural Hospitals Fund to invest in essential health infrastructure in regional areas, including new buildings, equipment and planning.								
Additional information (based on further advice provided):								
The fund would operate over 4 years and administer around \$500 million in grants each year. The costs of administering the fund would be in addition to the \$2 billion allocation.								
The proposal would start on 1 July 2025.								

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$2.1 billion over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would not be expected to have an impact beyond the 2025-26 Budget forward estimates period, other than for public debt interest (PDI) costs. A breakdown of the financial implications (including separate PDI tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

Administered expenses are as specified in the proposal, distributed evenly over 4 years. Departmental expenses were estimated based on the cost of administering similar programs and are in addition to the capped funding amount. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.¹
