Establishing an ongoing Regional Telecommunications Infrastructure Fund grant program

#### Summary of proposal:

The proposal would provide \$50 million per year in grant funding for a Regional Telecommunications Infrastructure Fund to enable local government and community groups to invest in local, place-based telecommunications projects. The program would encourage communities to propose the solution that fits their geography, needs and capabilities, rather than a one-size-fits-all approach.

The proposal would start from 1 July 2025.

Additional information (based on further advice provided):

The specific capped amount would be ongoing and indexed by the Consumer Price Index (CPI). Grant opportunities would be administered by the Community Grants Hub with departmental costs allocated in addition to the specified capped amount.

## Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by around \$214 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

## Key assumptions and methodology

The proposal is capped at a fixed annual amount of administered expenses, indexed to the CPI. Departmental expenses were estimated based on the cost of administering similar programs and are in addition to the capped funding amount. We assume that no funds allocated to a given year are left unspent.

Financial implications were rounded consistent with the PBO's rounding rules.<sup>1</sup>

Departmental expenses were informed by similar measures in the Commonwealth budgets from 2015-16 to 2021-22.
