Teach Maths for Australia								
Party:	The Coalition							
Summary of proposal:								
The proposal would deliver a new targeted Teach Maths for Australia program to recruit, place and train 105 new secondary maths teachers and 365 additional teachers in Teach for Australia's proven pathway.								
The funding would be distributed as \$0.4 million in 2025-26, \$1.3 million in 2026-27, \$9.8 million in 2027-28 and \$18.7 million in 2028-29.								
The proposal would be non-ongoing and start on 1 January 2026.								
Additional information (based on further advice provided):								
There would be \$10.0 million funding provided in 2029-30.								

Costing overview

The proposal would be expected to decrease the fiscal and underlying cash balances by \$30.2 million over the 2025-26 Budget forward estimates period (see Table 1). This impact reflects an increase in administered and departmental expenses.

The proposal would be expected to have an impact beyond the 2025-26 Budget forward estimates period. A breakdown of the financial implications (including separate public debt interest (PDI) tables) over the period to 2035-36 is provided at Attachment A.

The Parliamentary Budget Office (PBO) has not made any assessment as to whether the specified funding would be sufficient to meet the objectives of the proposal.

Key assumptions and methodology

The proposal is capped at a fixed amount, provided over 5 years from the commencement date as per the specification and additional information. Departmental expenses were estimated based on the cost of administering similar programs and are included within the capped funding amount. Administered expenses are as specified in the proposal, less expected departmental expenses. We assume that no funds allocated to a given year are left unspent. Financial implications were rounded consistent with the PBO's rounding rules.¹
